Board Meeting Minutes

Chairperson: Neil Anderton called for the meeting to come to order at $5: 10 \mathrm{pm}$ with the following attendees.

Concerns/Issues from TLPOA: Not present
Public Comments: None present.
Approval of April 2023 Minutes: A motion was made by John Blickenstaff to approve the April 18, 2023 meeting minutes as written. It was seconded by Gary Cannon and passed unanimously.

Approval of May 2023 Warrants: After review and discussion, a motion was made by Michael Wheelwright to approve the warrant list 14847-14870, including ACH payments for May and the credit card payment of $\$ 3,091.57$ for April. The motion was seconded by John Blickenstaff and passed unanimously.

Ratify April/May Payroll: John Blickenstaff made a motion to ratify the payrolls previously approved by two board members for pay periods ending 4/29/2023 and 5/13/2023. It was seconded by Michael Wheelwright and passed unanimously.

Manager Report: The extra runoff water and debris has caused issues in several areas.
The crew has been working on replacing a 23 -year-old transformer on the lower pump station that was buried in road base and shorted out.
The pump on the corner of Racoon and Buck had debris wash over it and was submerged. Jody rented a vac trailer to clean out the pump chamber.
There is a chlorinator on Lookout Mountain. The crew will install a chlorinator for the upper zone as soon as it is delivered. Currently they are chlorinating by pumping water from the lower tank and
mixing it. It must be monitored several times a day.
The power pedestal where Aspen and Lookout Spring meet was broken, the wires shorted, and burned. The crew had to pull wire across the road and put in a smaller transformer to continue to keep the alarms working and keep the tank levels visible.

Executive Session: Michael Wheelwright made a motion at 5:36 to enter executive session to discuss pending litigation and water rights. It was seconded by Neil Anderton and passed unanimously. Neil Anderton: Aye
