In 2022, the District applied to the Utah Division of Drinking Water (DDW) for financial assistance. At that time, no non-repayable grants were available. However, the DDW authorized a **loan of \$3,263,000 for 40 years at 0% interest** for the following projects:

- Develop two springs in the Upper Lone Pine area.
- Redevelop the West Side spring and an additional spring in the Upper Lone Pine area.
- Install a pipeline and pump station from the West side of Timber Lakes to move water from Westview Drive to the Ridgeline Drive tank.
- Replace Upper Lone Pine distribution and overflow pipeline.
- Install 6 new overflow meters to meet DDW and water right requirements (required by DDW to continue water service).
- Redevelop Lone Pine #2 Spring.
- Install 4 new magnetic flow meters to meet DDW and water right (required by DDW to continue water service).
- Install 100,000-gallon tank.
- Install seasonal chlorinators at Look out Mt. and Upper Lone Pine tanks.

In 2023, the Timber Lakes Water SSD Board hired Bowen & Collins Engineering (B&C) to complete a rate study addressing capital funding needs for through 2033. The rate study can be viewed and downloaded on the District's website, timberwaterssd.com. The District, in consultation with B&C, reduced the potential bond (**zero percent interest loan**) to \$2,200,000 by prioritizing immediate needs and including only the following capital improvements:

- Replace Upper Lone Pine distribution and overflow pipeline.
- Install 6 new overflow meters to meet DDW and water right requirements.
- Install 4 new magnetic flow meters to meet DDW and water right requirements.
- Install seasonal chlorinators at Look out Mt. and Upper Lone Pine tanks.
- Redevelop Lone Pine #2 Spring.
- Develop one spring in Upper Lone Pine area.

Postponing Capital Improvements does not always save money. In 2002, we proposed to bond \$3.5 million to replace aging water lines. The property owners said, "NO". We bonded in 2008 to replace the pipelines proposed in 2002 . The cost in 2008 was \$5.9 million dollars. It cost us \$2.4 million dollars to wait 6 years. If we bond (**zero percent interest loan**), the following chart details approximate rate changes to meet debt service for customers with all bonds attached to their accounts:

Customers who have pre-paid pre-existing bonds will be charged accordingly.
